# FOR THE GOOD OF THE CHAPTER

This is usually the last agenda item of the Board of Director's meetings, but also makes a good title to the discussion presented below. One of the two major fundraisers for the chapter is selling tickets for the **Ultimate Sport Show** and **Cottage and Lakefront Show** to be held at the **DeVos Center** in downtown Grand Rapids. The chapter retains all the receipts of the ticket sales, so investing time selling tickets is a very good use of our time.

You may not realize this, but our chapter started the sport show in 1945 with **Jack Locks, Sr.** as manager. This collaboration continues today with the selling of our combined Raffle & Sport Show Admission ticket and a premiere booth at the entrance to the show. This has been a very good thing for our chapter over the years, spreading the mission of the League and current conservation/environmental issues. In recent years our ticket sales have fallen off. As a result, a subcommittee was formed to see what could be done to improve ticket sales. The following paragraphs identify some of the ideas we had.

First, we processed the paperwork to get the ticket raffle approved and the tickets printed much earlier than in the recent past. This allows folks to sell them when attending other organizations they may be part of, or at outings they may attend, such as annual ice fishing get togethers. The goal was to give those who want to sell more opportunity to sell tickets.

We've added awards for high-ticket sellers. Sell 50 tickets and you earn a free property/lodge rental. Sell 20 tickets

and get free admission to the game dinner in April, when the winning raffle tickets are drawn. Also discussed, but will need board approval is that someone selling 20 or more tickets can get a free membership to give to a friend of their choice.

One of the more intriguing ideas was allowing other groups to sell tickets as a fundraiser. For example, the youth at a church could sell tickets. The tickets would have to be sold at the list price to meet state raffle regulations, but then the chapter could donate \$2 back to the organization. This is re-emphasizing a program that has great potential and was used in the past.

Lastly, it is important to remember that the ticket is a very good value. Tickets at the door are \$10, are \$8 with a newspaper coupon for \$2 and IKEs sell them for \$7. The Ultimate Sports show is a fun, diverse outdoors show, and the Cottage and Lakefront Living show is also very well attended and fun. On top of that, is the raffle, a chance with each ticket to win a Lake Michigan charter fishing trip for 4 with a two-night lodging casino package as the grand prize and \$100 as the second prize. No other admission ticket comes with these or any other prize. The odds are really good for winning a prize. Ask **Bob** and **Lorraine Radke** just how much fun it is to win or talk to **Dick Van Haften** or **John** and **Sandy Venman**.

# ROGUE RIVER WATERSHED COUNCIL WETLAND PROGRAMS

Over half of Michigan's wetlands have been drained and converted for agricultural use or other types of development. Wetlands serve a very important role in the landscape by improving water quality, flood storage and groundwater recharge. The loss of wetlands has increased the frequency and severity of flood events. Flooding always drains nutrients and unwanted chemicals, etc. into our streams and then to our lakes such as Lake Michigan. An important function of wetlands is that they reduce sediment and nutrients in surface water before it enters our streams, lakes and rivers. Restoring wetlands is one of the best conservation practices available for improving water quality and quantity.

There are state and federal programs that are available to restore these valuable wetlands. One program is the Natural Resources Conservation Service's Wetlands Reserve Program (WRP), which restores and protects wetlands converted to agricultural use. By enrolling in WRP, landowners with land that was formerly wetlands can convert these lands back to

their original state. WRP provides financial assistance to restore and protect wetlands, and to enhance degraded wetlands. For Kent County, landowners can receive up to \$3,689/acre in this program. The landowner can enter into either a 30-year easement or permanent easement that will insure the land is maintained as wetland habitat. In order to enroll land in WRP, the land must be owned privately or by a tribe and cannot have changed ownership within the previous 7 years, unless the landowner can provide adequate assurances.

Another program available is the U.S. Fish and Wildlife Service's Partners for Fish and Wildlife (Partners) Program. This program focuses on working together in a voluntary pro-active manner with private landowners to restore and enhance fish and wildlife habitat. Wetland restorations are generally focused where previous agricultural drainage provides an opportunity to restore hydrology, or put the "wet" back into altered wetlands. Projects often involve breaking or plugging a portion of a tile line,

blocking a ditch, or building a low dike or embankment. The U.S. Fish & Wildlife Service funds projects with cost-share assistance provided by **Ducks Unlimited**, other conservation organizations and government agencies, and landowners. Project construction is often completed with little or no cost to the landowner. Many landowners do contribute funds for permits or construction and in-kind services such as labor to prepare seedbeds and seed disturbed areas. Landowners are required to sign an agreement to preserve the project on their property for a minimum of 10 years. Landowners are also responsible for project maintenance.

The **Rogue River Watershed Council** is hosting an informational program to present more information via professionals about wetland restoration on **Monday, February 20** at the **Rockford North Middle School**. There is no cost and the program will last from 6:30 to 7:45 pm in the school cafeteria. For more information you may call me.

# ASIAN CARP

While we look forward to **The 21st Century Chicago Waterway System** study being done by **The Great Lakes Commission** and the **Great Lakes and St. Lawrence Cities Initiative** due out in late January 2012, our fellow Ike's are waging a similar battle on the upper Mississippi River. Here is the Asian carp problem as it is shaping up there. Our fellow Ike's, on the **Great Lakes Committee**, have a tremendous problem with **Asian Carp** working their way up the Mississippi River.



"The latter developed a comprehensive strategy that includes sampling and monitoring for **eDNA** at various points in the river, discussing triggers for positive eDNA hits (lock and dam closure is the only sure solution) etc. The Governor has held a couple of **Summits on Asian Carp** and is demanding action. One Congressional leader is drafting legislation that would help resolve barriers to Corps **ACTING** to close a lock and dam. Our new Mississippi

Below is a message from **Jill Crafton**, chairperson of the Great Lakes Committee, bringing the other members of the GLC up to date on some of their action. This is a preview of what we would have if the carp get established in the Great Lakes. If you have friends or relatives over in MN or WI that want to get involved they should get hold of Jill at [JWCrafton@rkmc.com](mailto:JWCrafton@rkmc.com) and she will point them in the right direction. Remember, there is strength in numbers!

River staffer working under **Brad Redlin** is supporting us and is amazing in the experience and gumption she brings to the table. Can't wait until you meet her, hopefully at National Convention in July. The Non-profit contingent of our **MN AIS Coalition** has engaged the media on a couple occasions and today culminated in a media press event to call for action. Since the locks are closing for the winter, the task was for a modified lock closure plan to be ready before opening the locks in the spring. Zentner, and others from **Friends of Mississippi, MN Responsible Property Owners** (fighting AIS in MN lakes), and **MN Conservation Federation** made statements and fielded questions on the need for action, the urgency for solutions, impact on navigation and effectiveness of barriers. Zentner was awesome in keeping the focus on the need for urgency and action.

"FYI: **Dave Zentner** and I have been participating in a coalition to stop Asian Carp from moving further up the Mississippi River and into the Minnesota and St. Croix Rivers. We have been working since April via conference calls and various meetings with DNR, Governor, and/or Corps (**John Goss** showed for that one hosted at DNR) to push for action. There was representation from a **Task Force** of scientists, **USFW**, **USGS**, and **MN DNR**.

# CONSERVATION ACTION TAKEN IN EARLY DECEMBER

Below is a letter that I signed onto for our **Dwight Lydell Chapter** and the **Michigan Division** as part of my responsibility as a **National Director** from Michigan. The letter is self-

explanatory and came to me via the **IWLA Great Lakes Committee**, of which **John Trimberger** and I are active. I believe IWLA Divisions and Chapters all along the Great Lakes

took similar action. It important to let members know what actions your representative are taking to protect the environment or what every the case may be.

Dear Premier McGuinty,

As we approach 2012, the undersigned groups are concerned that the **Great Lakes-St. Lawrence River Basin Sustainable Water Resources Agreement** signed in December, 2005 between the eight Great Lakes States and two Provinces has not yet fully come into force because the Province of Ontario still has not passed its regulations for exceptions to the Agreement for Intra-Basin transfers. We urge you to promulgate this regulation immediately. We understand you have already consulted on this regulation.

We understand that the **Wisconsin Department of Natural Resources** may be going out with a Draft **Environmental Impact Statement and Technical Review of the Waukesha Water** diversion application early in 2012. Pending the outcome of that process, the application could be forwarded by Wisconsin for Regional Body Review. It would be preferable to have the full Agreement in force for the first precedent-setting consideration of a major diversion from the Great Lakes at that time. The Agreement comes into full force, once the last jurisdiction brings measures to ban diversions and regulate exceptions into force.

Should this not occur, many procedural and status questions will be raised and the Regional Body Review process will be unduly complicated. Ontario will still be bound by the rules of the 1985 Great Lakes Charter, not by the Agreement. This raises concerns about how the other nine jurisdictions will proceed in utilizing the Agreement, and if and how Ontario will be accommodated in the review process. What, if any, are the implications for the parallel US Compact Review?

Important data from Ontario and Quebec on their baseline water use need not be submitted under terms of the Agreement until one year after the Agreement is in force. Will the impacts for these downstream jurisdictions and assumptions on cumulative Great Lakes water use be able to inform the decision-making on the historic Waukesha diversion proposal? Could this decision be challenged later once the full Agreement is in force?

We note that other jurisdictions, members of the **Council of Great Lakes Governors**, and Quebec have also expressed their hopes that Ontario would act on implementation by the end of this year (<http://www.cglg.org/news/TheCompass/Compass-2011-Issue3.pdf>). Thank you very much for your consideration; we urge you to take action quickly. The entire Great Lakes Basin is watching.
