CONSERVATION AND AWARDS BANQUET

We have a very timely and important speaker for this banquet that is of concern to all folks living in the Great Lakes basin. Grand Rapids **Mayor George Heartwell** will be the guest speaker. The banquet committee thinks you and your friends will be interested in coming on **March 2** to learn what should and can be done and how you might be able to help.

You all have heard the concern regarding **Asian carp** getting into the Great Lakes! Well we have the program of the moment and for you. Two Great Lakes groups, the **Great Lakes Commission** and the **Great Lakes and St. Lawrence Cities Initiative** began collaboration a couple of years ago to determine how the separation can be accomplished. Their goal was

to have their \$2 million comprehensive study completed by January 2012 a full 2 ½ years ahead of the **USCOE**. That was not only the goal but it will be completed on time. We are one of the first groups to find out what the results are. The study and report is titled **A 21st Century Chicago Waterway System**. It is very inclusive and will keep Asian carp from entering the Great Lakes through these waterways and keep aquatic invasive species from going either way because there will be a hydrological separation of these two great water basins. All of the associated problems of storm, sewage and barge traffic will also be dealt with. I know you will want to hear the message. Our own Grand Rapids Mayor George Heartwell, who is a member of the St. Lawrence Cities group's board of directors, will bring the message to us. We know he is well qualified to do the job.

So get your friends together and mail in your reservation ASAP. Seating is limited and could be sold out for this one.

LIFE MEMBERSHIP FOR STATE/CHAPTER DUES

Life membership in the **IWLA** is a worthy investment; however, it applies only for national dues and does not apply to state or chapter dues. Thus, life members in our chapter still pay state and chapter dues annually. So the **Dwight Lydell Chapter** board evaluated establishing our own "life membership," where someone who is a life member at national could become a life member at the chapter and not pay annual chapter/state dues.

The concept we've come up with is similar to the National **IKEs** life membership. They require a significant payment, the interest of such will pay the dues forever, or almost forever. **IWLA** life membership is 25 times the annual dues, which equates to an assumption that **IWLA** will make 4% annually on the investment over time, which will pay the annual dues. Chapter and state dues are \$14 per year, and assuming our investments could make 4%, the cost would be \$350 as a one-time payment. This seems a little high, so the **DLC** board projected a life dues payment assuming an investment return of 4.6%. This equates to a one-time life membership payment

for chapter/state dues of \$300. These dues would be applicable for chapter dues to any type of life membership, individual, family or benefactor.

The question then became: how to invest the life dues payment to make 4.6%, since banks don't pay that much. The answer is fairly straightforward now that we have the endowment/trust fund set up, the life dues payment could be deposited in our endowment fund. The endowment fund is set up to pay out earnings once a year. At that time we would receive earnings from the invested dues payment that will pay one's annual dues. The principal amount would remain invested and legally protected, not spent, and thereby will cover the annual dues payment in future years.

The administrative process is fairly straightforward. The membership secretary will track those who paid chapter/state life dues and can easily manage the dues process with national. The payment for life membership in the chapter would be deposited in the endowment fund and earnings would pay chapter and state dues

annually. Basically, this is done outside the national organization and within our chapter.

This program is for **life members**, who may have signed up at least in part, so they don't have to pay dues annually. Life membership fees also provide a continuing asset to further the goals of the **IKEs**. Life membership dues for both the chapter and **IWLA** dues payments are tax deductible. With this program, **DLC** is providing a benefit for the life members in our chapter. Currently we have 14 life members in our chapter.

This process is now straightforward because the chapter has an established a trust fund, which is described in another article in this newsletter. It is another step the board is taking to make membership in our chapter and the **Izaak Walton League** more convenient and worthwhile.

A SIGNIFICANT MOVE FOR OUR CHAPTER'S FUTURE A DLC TRUST/ENDOWMENT FUND IS ESTABLISHED

The **Dwight Lydell Chapter** now has its own trust, sometimes called an endowment, which can accept donations. The primary funds of the trust will remain invested and cannot be spent by the chapter or the trustees. Income from the trust investments will be directed to the Chapter's operating budget. This is a milestone for the chapter, as a legal endowment type of fund has been sought for over 6 years.

The Trust already has significant start-up investments. The chapter had a "restricted" account of donated funds (donated by past and current members); however, these were restricted by conscience only, and were not in a legal trust. The DLC board authorized transfer of these funds to the new Trust. In addition, there have already been 2 donations to the Trust, which now has just over \$50,000 invested. Up to 90% of the income generated by the Trust will be distributed annually to the Dwight Lydell Chapter of the IWLA. That way at least 10% of annual income generated by the fund will be retained in the fund and provide additional growth for the primary fund.

The trust or endowment fund is formally called the **Dwight Lydell Foundation** (Trust), and has been organized, registered and accounts established. The Trust was established with the help of Rockford attorney **Neil Blakeslee**. The Dwight Lydell board of directors appointed 3 board members to develop the Trust, who are now the initial trustees for the Trust. They are **Fred Eyer**, **Robert Stegmier** and **Ron Waybrant**. Future trustees will be selected from past or present board members of the DLC of the IWLA.

Income from the Trust will help stabilize our operating budgets and allow DLC to maintain and develop our facilities and offer more and better programs in the future. Many thanks are due to **Bob Stegmier** for his forward thinking and advocacy and for working to bring this idea to reality.

There was much fanfare regarding that the **Izaak Walton League of America** reaching its 90th anniversary on Saturday, January 14. This was highlighted with a special 90 years 1922 -1912 logo all over the walls and speaker podiums.

Oh yes, all attending had the opportunity to support the 90 years with a \$90 contribution to the **IWLA Trust**. All contributions to this trust are held with only the earnings from such fund returned to the operating budget. The contributions are being invested in conservative investments for long-term growth with some income. As your national director I supported the campaign with my personal contribution. I suspect all members will get a similar opportunity soon. Check your next *Outdoor America!*

There were good feelings among the attendees about the continued growth in the League's membership, which has grown at the average of 2.22 percent each year over the past four years with 2011 membership up by 3.34 percent. From the bar graph pictured below you see this is an exciting and important trend that all chapters need to work at to maintain growth.

We must keep the growth going for the strength of our chapters, the League and of course our "Mission." It is



often said and is true that membership is everyone's responsibility. The underlying feelings were that our League's Mission, based on a "common sense" approach throughout the league's chapters on the issues in "defending our soil, air, waters, woods and wildlife," makes it worthwhile to join. So one message I bring back from the day and a half of meetings is for all Michigan IKEs to keep membership growth on our minds and in our efforts. I believe this boils down to having asking the "how about joining" question whenever it seems appropriate. In Michigan we haven't kept pace with the rest of the chapters but I am confident with constant awareness and active "show" participation we can and will pick up the pace. I am looking forward to the day when the league's membership is back to 50,000. I know our first choice is to have someone join a chapter but the **MAL** (member at large) is certainly better than no membership. Folks living a significant distance from the chapter property may be reluctant to join the chapter so the **MAL** might just suit their interest. One thing I noticed at the national meetings lately is the **MAL** membership talked about much more these days in presentations. **MAL** memberships can be submitted directly to the national office via www.iwla.org or through the chapter's membership chairperson.

I am sure the meeting will be well covered in all matters and with pictures in the next *Outdoor America* magazine because the editor, **Dawn Mayhew Merritt** was busy all over the place taking pictures and giving presentations. She is a "ball of fire."

XL PIPELINE

I personally applaud **President Obama's** decision to delay the approval of this pipeline based on the concerns that Nebraska has about the current plan to have it run through a very environmental sensitive area in the Nebraska Hill Country called **The Sandhills** or The Sand Hills. I would hope any president would have taken such action under consideration based on any state's concerns of such nature and act accordingly. This is a region of mixed-grass prairie on grass-stabilized sand dunes in north-central Nebraska, covering just over one quarter of the state. This land is unsuitable for tilling for cropland, which the settlers found out about the hard way. Beyond this concern is that below and near the surface lays the **Ogallala Aquifer**, a vast yet shallow underground water

table aquifer located beneath the Great Plains in the United States. One of the world's largest aquifers, it covers an area of approximately 174,000 square miles in portions of the eight states of **South Dakota, Nebraska, Wyoming, Colorado, Kansas, Oklahoma, New Mexico and Texas**. While significant in all these states it lays under nearly the entire state of Nebraska. About 27 percent of the irrigated land in the United States overlies this aquifer system, which yields about 30 percent of the nation's ground water used for irrigation. In addition, the aquifer system provides drinking water to 82 percent of the people who live within the aquifer boundary. The major concern is that an oil spill would be devastating to the water supply.

I believe that in the long run an environmental suitable rout for the pipeline will be found and the pipeline will be built. I will remind you of the **IWLA** resolution passed last summer at convention did not oppose the pipeline but recommended the following point.

"Governmental permitting and regulatory agencies shall require the incorporation of fail-safe provisions, such as double wall pipe and leak detection monitors, in new pipeline construction and operation and in repairs of existing pipelines in order to protect surface water, groundwater, human health, soils and wildlife."

What happens on such land is that the organic materials get used up and some are oxidized, leaving the soil marginal for most farm production. The farming production is dwindling and there is some interest in some restoration. This program again is open to all and the various agriculture and government support programs will be discussed. No one should think this is the only area suitable for wetland protection that also turns out to be stream and creek protection within the RR watershed. This is usually the last agenda item of the Board of Director's meetings, but also makes a good title to the discussion presented below. One of the two major fundraisers for the chapter is selling tickets for the **Ultimate Sport Show** and **Cottage and Lakefront Show** to be held at the **DeVos Center** in downtown Grand Rapids. The chapter retains all the receipts of the ticket sales, so investing time selling tickets is a very good use of our time.

You may not realize this, but our chapter started the sport show in 1945 with **Jack Locks, Sr.** as manager. This collaboration continues today with the selling of our combined Raffle & Sport Show Admission ticket and a premiere booth at the entrance to the show. This has been a very good thing for our chapter over the years, spreading the mission of the League and current conservation/environmental issues. In recent years our ticket sales have fallen off. As a result, a subcommittee was formed to see what could be done to improve ticket sales. The following paragraphs identify some of the ideas we had.

First, we processed the paperwork to get the ticket raffle approved and the tickets printed much earlier than in the recent past. This allows folks to sell them when attending other organizations they may be part of, or at outings they may attend, such as annual ice fishing get togethers. The goal was to give those who want to sell more opportunity to sell tickets.

We've added awards for high-ticket sellers. Sell 50 tickets and you earn a free property/lodge rental. Sell 20 tickets

and get free admission to the game dinner in April, when the winning raffle tickets are drawn. Also discussed, but will need board approval is that someone selling 20 or more tickets can get a free membership to give to a friend of their choice.

One of the more intriguing ideas was allowing other groups to sell tickets as a fundraiser. For example, the youth at a church could sell tickets. The tickets would have to be sold at the list price to meet state raffle regulations, but then the chapter could donate \$2 back to the organization. This is re-emphasizing a program that has great potential and was used in the past.

Lastly, it is important to remember that the ticket is a very good value. Tickets at the door are \$10, are \$8 with a newspaper coupon for \$2 and IKEs sell them for \$7. The Ultimate Sports show is a fun, diverse outdoors show, and the Cottage and Lakefront Living show is also very well attended and fun. On top of that, is the raffle, a chance with each ticket to win a Lake Michigan charter fishing trip for 4 with a two-night lodging casino package as the grand prize and \$100 as the second prize. No other admission ticket comes with these or any other prize. The odds are really good for winning a prize. Ask **Bob** and **Lorraine Radke** just how much fun it is to win or talk to **Dick Van Haften** or **John** and **Sandy Venman**.
